Terms and conditions of the Contractual Appointment

- 1. The contractual appointment will be made initially for one year and extendable till the completion of project (3 years) based on performance.
- 2. The recruited project staff are eligible for leave as per project/University of Delhi rules and will have to give an undertaking at the time of joining.
- 3. Mere fulfilling the essential qualification does not guarantee the selection. The applications received will be screened and the shortlisted candidates will be intimated through e-mail provided and the information regarding the interview will be shared with the shortlisted candidates on the e-mail id provided by the candidate. Candidate selected against the post will be intimated via email.
- 4. The conditions for employment will be same as that of the ICMR project staff on contract basis.
- 5. Age, qualification, experience etc. will be reckoned as on the last date of submission of application form. Age relaxation will be applicable as per GOI rules.
- 6. Hostel accommodation of any kind is not available with the Institute.
- 7. These positions are meant for temporary projects and co-terminus with the project.
- 8. Engagement of the above advertised Project Human Resource Positions will depend upon availability of funds, functional requirements, and approval of the Competent Authority.
- 9. Qualification & Experience should be in relevant discipline/ field and from an Institution of repute. Experience should have been gained after acquiring minimum essential qualification.
- 10. Persons already in regular time scale service under any Government Department/ Organizations are not eligible to apply.
- 1. No TA/DA will be paid to attend the Interview/ Personal discussion and candidates must arrange transport/accommodation themselves.
